STATUTORY UPDATES

1. Revised formats for interested parties

DGTR has prescribed new application format for domestic industry and questionnaire formats for exporters, importers and users with an objective to reduce compliance burden on respective interested parties. Different formats are prescribed as per the following Trade Notices:

Trade Notice No. 05/2021: Domestic industry

• Trade Notice No. 06/2021: Foreign producer / exporter

Trade Notice No. 07/2021: Unrelated importer

Trade Notice No. 08/2021: User industry

Trade Notices No. <u>05/2021</u>, <u>06/2021</u>, <u>07/2021</u> and <u>08/2021</u> dated July 29, 2021

NITYA Comments: The revised formats are expected to reduce burden on interested parties as the new formats do away with certification requirements and have streamlined information and data to be collected.

2. Guidelines for fragmented domestic industries to file AD/CVD application

DGTR has issued guidelines to enable fragmented domestic industries to file applications for AD/CVD measures.

In the absence of clarity on procedures to be followed by fragmented industries under the existing provisions, the trade notice now allows fragmented domestic producers constituting domestic industry to file basic injury information as per prescribed format. Further, DGTR may now resort to selecting a sample set of producers and seek additional information for calculating injury margin.

3. Clarification with respect to revised formats issued by DGTR

DGTR has issued clarification with respect to applicability of Trade Notice Nos. 05/2021, 06/2021, 07/2021, 08/2021 and 09/2021 issued on 29th July 2021, by stating that while the new formats of application and questionnaires are applicable from immediate effect, stakeholders have the option to submit information as per old formats till October 31, 2021.
